Elisa has the right to check the customer's credit details and address details for the purposes of making the agreement. The ownership change may require that a deposit or security is paid. In this case, the agreement enters into force when the deposit or security has been paid. By signing the form, both the current owner and the new owner of the agreement, accept the change as well as Elisa's valid general and service-specific delivery terms, which are available at elisa.fi/sopimusedot. If the change is made for a company, the signatory must be authorized to sign, or they must have a power of attorney. A power of attorney that has not been filled in adequately cannot be accepted.
