## **Direct Wholesale Roaming Access Reference Offer**

#### Scope

This document constitutes the unilateral reference offer of Elisa Corporation to direct wholesale roaming access seekers in accordance with Regulation 531/2012. The reference offer includes all the wholesale roaming services which are necessary for an access seeker to offer retail roaming services typically offered under wholesale roaming agreements on regulated terms.

## **Direct Access Roaming Prices**

Elisa Corporation shall charge the Direct Wholesale Access Seeker the following rates for each transaction type from 1 January 2021:

Service	Tariff	Service Description
Voice MO (Mobile Originated)	0.032 Euro/minute	Mobile Voice Call originated and terminated within the EU territory
SMS (Short Message Service)	0.01 Euro/event	Short Message Service originated within the EU territory
Data	3 Euro/GB	Data traffic originated within the EU territory

## **Direct Access Roaming Services**

As per Elisa's AA.14 OpData.

## **Technical Implementation**

Elisa Corporation uses the following industry standards for IREG testing:

- · IR.21 to test and confirm interconnection and interoperability between networks.
- IR.24 to certify and ensure correct functioning of circuit switched voice and SMS.
- IR.35 to certify and ensure correct functioning of packet switched services.
- IR.60 to certify and ensure correct functioning of CAMEL prepaid services.

The full list of these technical standards and protocols are available upon request by the access seeker.

## **Security and Data Privacy**

The parties commit themselves to observe the secrecy rules and maintain the data secrecy according to the data security and data privacy obligations under the European Regulatory Framework and further outlined in the direct wholesale access agreement.

#### **Fraud Prevention**

The parties shall implement fraud procedures as specified by the GSM Association within Binding PRD BA.20.

## Requirements on the Access Seeker

Elisa Corporation may require the following from the access seeker:

- A bank guarantee and/or upfront payment prior to commencement of the service start and during operations.
- Initial estimate of traffic volume per roaming service covered in the request.
- Provide the necessary information for system interconnection at the start of the service and on a continual basis.
- · Provide test U/SIMs.
- · Billing and transfer information.
- Any other technical information or information necessary to launch or assess compatibility of the service
- · Contact data of the access seeker.



# Permanent roaming or anomalous or abusive use

Permanent roaming or anomalous or abusive use of wholesale roaming access for purposes other than the provision of regulated roaming services to roaming providers' ("HPMN's") customers while the latter are periodically travelling within the Union is prohibited and the violation will be charged as specified in the agreement. This charge will be invoiced separately on a monthly or yearly basis afterwards.

As an example an IMSI in a M2M/IoT unit roaming in Elisa's network for more than 14 days within a month or 30 days within a year; or any service offering targeted to customers residing in Elisa's licensed operating area ("Finland") using wholesale roaming access are criteria for the charging. When Elisa detects permanent roaming or anomalous or abusive use of wholesale roaming access it will give a notice at least 14 days before applying the charging during which period the HPMN may correct its behavior to avoid the charging.

## **Duration of the Agreement**

When the agreement comes into force it shall remain in force unless terminated by one of the parties in writing subject to a notice period of six months or terminated as per the conditions stipulated in the direct wholesale roaming access agreement.

#### Modifications to the Reference Offer

This reference offer will be updated as a minimum on an annual basis in order to update the regulated prices. If new methods of roaming access become available, Elisa Corporation will update this reference offer and amend any existing direct wholesale roaming access agreements to reflect such new methods of roaming access, including the processing of requests and access to necessary facilities.
